Hurricane Irene & JARS

Whenever there is a storm of any magnitude or any major event in Johnston County the county activates the EOC (Emergency Operations Center) Johnston County utilizes the "Incident Command System". Part of that system includes the utilization of Amateur Radio for Emergency Communications at the EOC and any shelters that are opened for evacuees, whether they be local or from other counties. In this case, we were the designated evacuation site for

Carteret County and had to open one shelter here in Johnston County at Smithfield-Selma High School.

The Johnston County EOC depends on us, JARS, to provide the radio operators to man the EOC and shelters. Each county has an "E.C." Emergency Coordinator and in some counties an assistant E.C. In order to be an E.C. or to work in the shelters, or for that matter, in any position in the "ICS", there are certain courses that are required. These are: [IS-100.b - \(ICS 100\) Introduction to Incident Command System](#), [IS-200.b \(ICS 200\) ICS for Single Resources and Initial Action Incidents](#), [IS-700.a National Incident Management System \(NIMS\), An Introduction](#) and [IS-800.b National Response Framework, An Introduction](#). All these and more courses can be found at:

There are many other courses that you can take that are not required. I was lucky or unlucky, depending on which way you want to look at it, to be the one that was acting as E.C. for the duration of Hurricane Irene. Luckily, I was able to find enough people to man the EOC and the one shelter we had open. We were lucky this time that it was a short lived event and a light event in the fact that

the EOC and shelter both maintained electricity and phone coverage. This is not always the case. For those that remember when Hurricane Fran came through, we had several shelters open and the EOC remained in operation for several days and we were able to provide the support needed.

When I first joined after getting my license, the meetings were always full and lively. It was pretty hard to find an empty seat and the tables were crowded. It was also not too soon after I joined that I saw a president step down and walk out of the meeting leaving his membership behind. Things have not always been so obvious to me through the years, and a lot still confuses me. When it comes time to elect new officers, the president spot is always exciting to see who will take the challenge. Those without thick skin need not apply. Byron was always great and he shot straight and told you how he saw it. We had some good programs for the meetings and the meetings would run for a long time with most of the

members getting to check-in to the nightly net on their mobiles, but sometimes the net was already over.

Friday and Saturday night nets get a lot of attention and I like that. E-mail the secretary's report of the Thursday night meeting to all the members by Sunday night following the meeting. If some important information was discussed (i.e. raising membership dues) then I believe we should be getting that information out to the members as soon as possible instead of having to wait a week before the next meeting to hear about it, IF the secretary has turned in a report of the last meeting's minutes.

HAVE A PROGRAM FOR THE MEETING. If the membership fee of the JARS club will be raised to its new cost, then give me a reason to come to the meeting and make it enjoyable. I know that these are difficult times and that the prices of everything are going up, but if I'm going to make the decision to attend the meeting, feed me some new information about ham radio and teach me something I didn't know. I could take my membership money and join ARRL and get a magazine

subscription that could cover lots of new information, but I would like to see the club in action and applying new projects and techniques at the local level.

Reduce the number of meetings that take place at the Panther Branch Center.

There are certain times of the year in which we need the meeting place: JARS auction in February, Presidential picnic in May, Christmas Dinner in December. And sometimes we have a gathering in which we most of us meet in a large group and see each other too: Field Day in July and JARS Fest in November. So, why can't we reduce the number of meetings that we have at the center to maybe just 6 in a year? Has anybody thought about having a meeting over the air(our meetings are open to the public, so there shouldn't be a problem with discretion)? We threw around ideas about meeting at another place that would be **FREE**, but that didn't seem to amount to much. Golden Corral at 40-42, I think, would be a great place to start a few trial meetings to see how bad the crowd is and how long we could keep the meeting there until they throw us out for being too loud and rowdy? Plus it's actually in JOHNSTON COUNTY. I would much rather meet at a place for free that have to raise our membership dues again next year.

Do we need to have a separate JARS website?

Concerning this matter, I've tried to access the JARS.net website and have not had any luck getting it to come up. For just an easier fix, could we just make a Facebook page and keep it members only accessible? I could see us uploading more pictures and getting a lot of information out to the members in an up-to-the-minute kind of fashion and be able to have discussion boards so we can help out those who need it.

I know that I don't have the best track record for attending JARS meetings and that is due to many reasons dealing with being married and financial situations, but I'm looking forward to being at more meetings in the coming year, and definitely involved with more amateur radio activities. I know that everybody's life is not the same and we all have our own situations that life throws at us, but I do think we can find common ground. I love to be one of the first to show up at JARS fest to help set up and be the last to get all the tables put up in the Lee farm house as well as help raise as many antenna at field day to make radios get on the air. Let us be willing to give the correct length for a 1/4 w 2 meter antenna without berating somebody for not knowing.

FCC Rules and Regulations,
Subpart A, 97.1:

The rules and regulations in this Part are designed to provide an amateur radio service having a fundamental purpose as expressed in the following principles:

(a) Recognition and enhancement of the value of the amateur service to the public as a voluntary noncommercial communication service, particularly

with respect to providing emergency communications.

(B) Continuation and extension of the amateur's proven ability to contribute to the advancement of the radio art.

(C) Encouragement and improvement of the amateur service through rules which provide for advancing skills in both the communications and technical phases of the art.

(d) Expansion of the existing reservoir within the amateur radio service of trained operators, technicians, and electronics experts.

(e) Continuation and extension of the amateur's unique ability to enhance international goodwill.
